

MINUTES OF THE CITY COUNCIL OF LAUREL

JANUARY 2, 2018

A regular meeting of the City Council of the City of Laurel, Montana, was held in the Council Chambers and called to order by Mayor Mark Mace at 6:30 p.m. on January 2, 2018.

City Judge Jean Kerr performed the swearing-in ceremony for Heidi Sparks, Irving Wilke, Bruce McGee and Richard Klose, newly-elected Council Members.

There were applause and pictures were taken.

Mayor Mace handed the gavel to Council President Eaton, who led the remainder of the Council meeting.

Motion by Council Member McGee to approve the minutes of the regular meeting of December 19, 2017, as presented, seconded by Council Member Herr. There was no public comment or council discussion. A vote was taken on the motion. All six council members present voted aye. Motion carried 6-0.


There being no further business to come before the council at this time, the meeting was adjourned at 6:47 p.m.
