RESOLUTION NO. R16-70

**RESOLUTION RELATING TO SPECIAL IMPROVEMENT
DISTRICT NO. 114; FINAL LEVY OF SPECIAL
ASSESSMENTS FOR MAINTENANCE COSTS ON
PROPERTY WITHIN THE DISTRICT FOR THE PURPOSE
OF PAYING THE COSTS OF MAINTAINING CERTAIN
LOCAL IMPROVEMENTS**

BE IT RESOLVED by the City Council of the City of Laurel (the "City"), Montana, as follows:

Section 1. The District; the Improvements. The City has created a special improvement district pursuant to Montana Code Annotated, Title 7, Chapter 12, Parts 41 and 42, as amended (the "Act"), denominated Special Improvement District No. 114 (the "District"), and has undertaken certain local improvements in the District, including landscaping in two public parks and related improvements (collectively, the "Improvements") to benefit property located therein.

Section 2. Maintenance Costs. Pursuant to Sections 7-12-4136 and 7-12-4179 of the Act and as stated in Resolution No. R12-53, duly adopted by the Council on July 17, 2012 (the "Resolution of Intention") and as provided in published and mailed notices, the City intends to maintain the Improvements and to pay costs of such maintenance from special assessments to be levied against property in the District. The annual cost of such maintenance is \$5,000.00.

Section 3. Method of Assessment. (a) Pursuant to the Resolution of Intention, this Council determined to levy special assessments to pay the costs of maintaining the Improvements on the basis or bases therein provided as authorized by the Act.

(b) This Council hereby ratifies and confirms that the assessment of costs of the maintenance of the Improvements against the properties benefited thereby as prescribed by the Resolution of Intention are equitable and in proportion to and not exceeding the special benefits derived from maintaining the Improvements by the lots, tracts and parcels to be assessed therefor within the District, and the special assessments authorized by this resolution are in accordance with the methods and do not exceed the amounts prescribed by the Resolution of Intention.

Section 4. Public Hearing; Objections. This Council, on August 2, 2016, adopted Resolution No. 16-67, pursuant to which this Council declared its intention to levy and assess the special assessments for maintenance costs in the District. Notice of passage of the resolution was duly published and mailed in all respects in accordance with law, and on August 16, 2016, this Council conducted a public hearing on the levying and assessment of the special assessments.

This Council has considered the objections submitted to the proposed assessments for maintenance and other comments made at the public hearing. This Council has determined not to modify any of the special assessments appearing in the proposed maintenance assessment roll attached as Exhibit A to such resolution.

Section 5. Final Levy of Assessments. (a) The special assessments for the costs of maintaining the Improvements shall be levied and assessed against properties in the District in accordance with the methods of assessments referred to in Section 3.

(b) Exhibit A to this Resolution (which is hereby incorporated herein and made a part hereof) contains a description of each lot, tract or parcel of land in the District to be assessed for the costs of maintaining the Improvements, the name of the owner, if known, the total amount of the special assessment levied against each lot, tract or parcel for the costs of maintaining the Improvements, the amount of each partial payment of the special assessment for the costs of maintaining the Improvements, and the day when each such partial payment shall become delinquent (the "SID 114 Maintenance Assessment Roll").

(c) The SID 114 Maintenance Assessment Roll is exclusive of special assessments to be levied against lots, tracts or parcels in the District to finance the costs of the Improvements and incidental costs.

Section 6. Certification of Assessments. A copy of this Resolution, including Exhibit A hereto, certified by the City Clerk shall be delivered to the County Treasurer within two days after the adoption hereof.

Section 7. Further Actions. Officers of the City and the County are further authorized and directed to take all actions as may be required by law to assure that the special assessments levied by this resolution are duly certified, assessed and collected in accordance with law.




