That for the purpose of paying for the improvements constructed in Special Improvement District No. 114 of the City of Laurel, Montana, the City hereby levies and assesses \$4,983.84 on the attached described property in the City of Laurel, Montana, owned by the persons respectfully indicated in installments as shown, payable in the year indicated (Exhibit A).
- Section 2. That the said installment payable in the year 2016 shall be placed on the tax roll for the said year and collected in the same manner as other taxes.
- Section 3. That the said installment shall become delinquent at five o'clock, p.m., on the 30th day of November 2016 and at five o-clock, p.m., on the 31st day of May 2017, when such payments are due and payable.
 - Section 4. That when the assessments become delinquent, the property is sold for taxes.
- Section 5. The revenue collected under this resolution shall be paid into the SID No. 114 Bond Sinking Fund of the City of Laurel, Montana.
- Section 6. The Clerk-Treasurer is hereby directed upon final passage and approval of this resolution to certify a copy of the same to the County Treasurer of Yellowstone County, Montana.
