The Fire Departments breathing air compressor became inoperable the beginning of April. It fails to advance out of 1st stage. A discussion with the Technician from DXP it was determined that the compressor was bad.

The breathing air compressor fills the SCBA bottles. It draws in fresh outside air, compresses it and fills the SCBA's.

I received three quotes for new compressors and DXP was going to look at sending a repair quote. After DXP researched parts it was determined that they could not find replacement part for our compressor.

Based off the information from DXP and the fact of the importance of the equipment in the operations I am requesting the purchase of a new compressor in the amount of \$45,325.00 from MES (Municipal Emergency Services). They are the same suppliers of our SCBA's.

After discussing with the CAO and City Clerk it's suggested to use about \$4200.00 from fire donations and about \$42,000 from the Fire CIP funds.

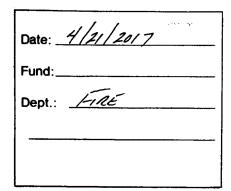
