WHEREAS, the application appears complete, the project is eligible for grant assistance and LURA recommends funding of the same; and

WHEREAS, grant amounts that exceed \$5000 must be approved by the City Council pursuant to the Grant Program Regulations.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Laurel, Montana, that Ken and Peggy Miller are awarded a \$6,400 grant from the City's Tax Increment Financing District Fund for the improvements, including technical assistance, for the Property located at 201 East Main Street; and

BE IT FURTHER RESOLVED, the Mayor, CAO, and City Clerk Treasurer are authorized to utilize the appropriately designated accounts to pay the grant upon submission of the required documentation from the Property Owners.

Hi Ben,

So my understanding is that at this point in time, the Millers would be applying for the Technical Assistance Grant to have A&E help them design a project for façade improvements. Each building can apply for a grant as they are separate projects. The façade grant and large grant are meant to implement the Technical Assistance design work that was done. You have the amounts correct for façade limits. The Large grant does not have a cap but is still a 1:1 matching grant, same as the façade. LURA only has the power to spend up to \$5,000 without council approval, with the larger building being \$7,500 I would have to take that to council for their approval with a recommendation from LURA. That usually isn't a problem.

a. It appears that this grant is for actual construction and not just design services? Façade and Large grants are for the construction. The Technical Assistance grant is for design.

b. I read the part about this being a reimbursement grant, is there a pre-approval process so the owner knows how much assistance they can count on before the construction starts? I could see this altering the direction of the design. It depends on the grant but yes there is, the façade grant will be given to the board on the third Monday of the month and after that meeting you will know the amount awarded (it is usually the matching amount unless it is over \$5,000 then it will go to the next council meeting) and the funds are available immediately with the proof of paid invoices. The large grants are due around May 1<sup>st</sup> and the small committee will meet one day, about a week after they are due, and distribute the \$100,000 to the eligible applicants. After that meeting the amounts are pretty set and have never changed with Council approval, the funds then become available July 1<sup>st</sup>.

c. I see the May 1st 2017 deadline, but we must be in the next year of funding? I am assuming we will need a finalized design to apply for this grant... It helps, the better plan and amount requested on that application the better you are with the committee awarding the money.

d. Is there money left in the large grant this year? There is not Large Grant funding available this year however there is always facade grant and technical assistance grant money available.




