RESOLUTION NO. R15-19

A RESOLUTION OF THE CITY COUNCIL TO ADOPT A RIGHT-OF-WAY CHARGE FOR FISCAL YEARS 2013-2021 AND TO APPROVE A FIXED RENTAL CHARGE FOR SUBSEQUENT FISCAL YEARS.

WHEREAS, the City Council previously adopted an Administrative Cost Allocation System and Right-of-Way Rental Charge through passage of Resolution No. R09-44; and

WHEREAS, Resolution No. R09-44 established an annual rental charge for fiscal years 2009 and 2010 for the City's rights-of-way and the charges were determined to be reasonable, equitable and in the best interest of the City; and

WHEREAS, the Mayor and Staff periodically review the sufficiency of the right-of-way charges and recommend adjustments to the charges for the City Council's consideration and adoption; and

WHEREAS, the Mayor and Staff have reviewed the right-of-way charges for the fiscal years listed on the attached "Exhibit A" and have determined the charges are reasonable, equitable and in the City's best interest; and

WHEREAS, the Mayor and Staff currently recommend the City Council's adoption of the right-of-way charges for the fiscal years as listed on Exhibit A attached hereto and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Laurel, Montana, that the Right-of-Way Rental Charges provided on "Exhibit A" are hereby adopted until fiscal year 2021 with a 3% increase each fiscal year with charges not to exceed \$200,000; and

BE IT FURTHER RESOLVED that the adopted schedule of charges shall remain in effect until further action of the City Council.
