WHEREAS, the City Council previously authorized Task Order No. 32 – 2015 Street Maintenance Project, and in response publicly advertised the project and received one (1) responsive bid; and

WHEREAS, Hardrives Construction submitted the only bid; and

WHEREAS, Great West Engineering, Inc. recommends to the City Council that it select the bid submitted by Hardrives Construction, at the bid price of \$89,344.00.00 to complete the project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Laurel, Montana, that the City Council finds that the City of Laurel has followed its procurement policies that required advertisement and acceptance of bids for the project as required by the State of Montana; and


BE IT FUTHER RESOLVED that acceptance of the bid submitted by Hardrives Construction is in the best interest of the City of Laurel and that the Mayor is authorized to sign a contract for \$89,344.00 with Hardrives Construction for completion of the 2015 Street Maintenance Project.



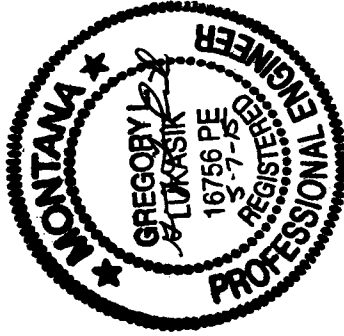
