PASSED and ADOPTED by the City Council of the City of Laurel, Montana, this 19th day of May, 2015.



Drive, Filter and Controls will be installed in a Nema 3R panel with filters and fans for cooling.

There will be a solid state transducer connected to the VFD for pressure control. Completely assembled and tested and installed.

For wireless control from the cemetary building. The control will consist of adjustable timer and a transmitter with antenna to provide for on/off an cycle control. Also at the VFD panel there would be receiver installed to control the VFD by way of wireless.
